**INSTRUCTIONS: NOTICE TO TAXPAYER**

**1. Deadline for return.**

If you were a resident of, a property owner in, or operated a business in Phelps County, Missouri, as of January 1st, 2019, please fill out the assessment list and return it to the Assessor's Office **BEFORE THE FIRST DAY OF MARCH**. Businesses should file a "Business Personal Property Declaration" form. Please call us and we will send you one of these forms.

If you moved from Phelps County before January 1st, 2019, you will not owe taxes in Phelps County. Please return this list stating your new address and date moved.

**Failure to return your Assessment List will result in a Penalty.**

Late Personal Property Lists - Sec. 137.280 RSMo requires the assessor to assess a penalty on any person who fails to return his personal property tax list by the deadline.

**2. Did you receive more than one personal property assessment list?**

**3. Did you claim a vehicle not titled to you?**

If title of car is not in the name of taxpayer on front of return, or is a leased vehicle, be sure to also show the name of the title holder.

**4. Are you active duty military?**

Active duty military personnel with Home of Record or State of Legal Residence of Missouri, or where LES indicates Missouri is the state to which wage and earnings income tax is being paid, are considered residents of Missouri and are therefore subject to personal property assessment and taxation, regardless of where they are stationed or where vehicles are licensed, in accordance with the Soldiers and Sailors Relief Act of 1940. **5. Tractor-Trailer Owners:**

Show same number of miles as reported to MO Highway Reciprocity Commission for last year's apportioned plates. Failure to report total miles and total Missouri miles will result in 100% assessment.
